## **Abatement Process:**

The City estimates that approximately 30 properties will be added to the mow list per season, most of them requiring multiple mowings. However, the actual number can vary significantly and cannot be guaranteed.

The City of Fridley uses the following process for most lawn mowing abatements completed within the City. The City will email the contractor the address of the property that needs to be mowed. The contractor will mow the property within two (2) business days from receiving the email from City staff, unless they communicate with staff why the abatement can not be completed in time. The contractor will continue to mow the property every 14 days unless one of the following occurs.:

- The contractor arrives at the property to mow and it's clear the property has been mowed since the last time the contractor was at the house.
- City staff communicates with the Contractor to remove the property from the mowing list.

The above process with be completed at each property unless otherwise noted by City staff in the original email.

Staff will not be present at each abatement but will be available by phone if there is an issue at a property.
