



# 2024 Street Rehabilitation Project

Construction Update

October 18<sup>th</sup>, 2024

## **Signage & Pavement Markings (Channel Road, Lucia Lane, 66<sup>th</sup> Avenue, Norton Avenue):**

This week, the Contractor installed the second and final layer of bituminous asphalt on Lucia Lane, Channel Road and 66<sup>th</sup> Avenue. The Contractor also installed bituminous asphalt speed humps along Channel Road.

On Saturday, October 19<sup>th</sup>, the Contractor will reinstall pavement markings on Lucia Lane, Channel Road and Norton Avenue. Residents are asked to use caution when navigating fresh pavement markings. Next week, the Contractor will reinstall previously salvaged roadway signage on Lucia Lane and Channel Road and begin minor corrective work in all project areas.

## **Bituminous Joint Saw & Seal (Channel Road, Lucia Lane, 66<sup>th</sup> Avenue, Norton Avenue):**

Next week, the Contractor will also begin bituminous joint saw & seal operations on all project streets excluding Buchanan Street. This work will include sawing the new pavement at prescribed locations and filling the cuts with a sealant.

The bituminous saw & seal process creates defined joints in the pavement that allow for expansion and contraction during the freeze/thaw cycle, minimizing the early development of wandering cracks and prolonging the life of the new pavement.

## **Street Parking:**

In order to provide the Contractor with room to work and prevent any damage to vehicles or personal property, on-street parking in areas of active construction will be restricted, unless otherwise permitted, during working hours (7:00 am – 7:00 pm, Mon – Fri). Vehicles parked within the immediate work area during active construction may be subject to enforcement.

***Please note that all construction scheduling is tentative, weather-dependent, and subject to change.***

## **Construction**

The Contractor's hours will be from 7:00 a.m. to 7:00 p.m., Monday-Friday. There is potential for occasional work outside of these hours upon City approval.

Please keep in mind that this type of construction may generate noise, dust, mud, and be disruptive to the area. Please be patient with the Contractor and contact us if you have any concerns we can help with.

## **Resident Access**

The City and Contractor will work to minimize inconvenience to residents during construction. Residents can expect to have driveway access during construction except when major construction events are occurring on their street. We ask that residents, including children, remain outside the immediate work zone and exercise caution navigating the project area wherever you see workers, equipment, or warning signs.
